The Organisation

The Team

Based in the Thames Solent Area Team, you will be working as a warden in our wardening team, providing an on-the-ground wardening service on the Thames Basin Heaths Special Protection Area (TBH SPA). Working closely with the SPA landowners and managers and other key partners (including local authorities, Wildlife Trusts, the RSPB, Ministry of Defence, Forestry England and The Crown Estate), you will be engaging directly with the public to raise awareness amongst visitors of the importance and sensitivity of this internationally important heathland site.

The Role

The Thames Basin Heaths Partnership (TBHP), hosted by Natural England's Thames Solent Team, is fully funded from developer contributions, and is overseen by the TBH Joint Strategic Partnership Board (JSPB), a body comprising 11 local authorities, and Hampshire and Surrey County Councils. Working in partnership with Natural England colleagues, the TBH local authorities, SPA land owners and managers, and other stakeholders, you will support the project and enable it to achieve its objective of helping to protect the SPA from recreational pressures arising from new housing development.

As Warden you will;

- Work as part of the TBHP warden team, providing an on-the-ground wardening service on the TBH SPA. Working closely with the SPA landowners and managers and other key partners, you will be engaging directly with the public to raise awareness amongst visitors of the importance and sensitivity of the SPA.
- Promote the use of Suitable Accessible Natural Greenspace (SANG) sites as an alternative destination to SPA visitors.

- Provide a consistent SPA/ SANG message, including the use of promotional and educational material.
- Assist with educational activities, both on and off the SPA, and contribute to events, workshops, guided walks, etc., as required.
- Encourage responsible dog walking and discourage negative recreational activities where they impact on the SPA and reporting illegal activities to landowners/ managers.
- Work with existing landowner/ land management staff to assess visitor infrastructure and focus on the practical experience of visitors to identify on-the-ground improvements.
- Be willing to learn new ways of working and new technologies.
- Admin tasks where required. E.g keeping important internal admin up to date and entering data accurately and promptly, such as wardening stats, onto system.
- Other activities as required.

Key Capabilities

If you are successful, we expect you to have a certain level of capability in a range of activities. At the interview you will be asked questions related to your technical skills as well as to see how close you are to these levels in the following activities, which are drawn from the skills framework for this role:

- Work proactively and collaboratively with stakeholders and partners to identify and secure opportunities to deliver gains for people and nature. (Practitioner)

- Manage and deliver your work to meet agreed targets and deadlines and apply the relevant methodologies and tools for collecting data. (Practitioner)
- Understand and apply relevant policy, legislation, governance frameworks and strategies to your work. (Basic)

Working Safely

- Apply the principles of risk management and adopt safe working practices for yourself and the people you work with in everything you do. (Basic)
- Understand the duty of care owed to all visitors, contractors or others on the SPA, and adhere to appropriate legislation and Natural England policies and procedures (Basic)

Technical/specialist knowledge/qualifications

Essential:

- A relevant qualification or experience in education or countryside/animal management, nature conservation, environmental science, on the ground wardening service or a related discipline.
- Knowledge of the lowland heathland habitat and the development and recreational pressures and issues affecting it.
- Experience of, and confidence in engaging with the public, particularly where this
 experience has been gained from having worked outdoors in a nature conservation/
 countryside access-related role.
- Knowledge of Natural England's purpose and how this work will contribute to its aims and objectives.
- Good written and verbal skills to enable effective communication with a range of internal and external partners
- Ability to use Microsoft Word, Excel, PowerPoint, Microsoft Teams, Outlook & other technology as required.

Desirable:

- Experience of, and confidence in engaging with children in an educational setting.
- Experience of, and confidence in engaging with dogs and dog walkers.
- Knowledge of countryside access/ rights of way, and nature conservation issues.

Additional information

Location of the role:

You must be able to travel to the TBH SPA on a daily basis. The role requires some weekend/ early morning and evening work. The TBH SPA and local partners fall within parts of Berkshire, Hampshire and Surrey.

As part of the role you will be required to regularly travel to our office which is located at Heather Farm, Woking GU21 4XY

A current, full driving license and reliable access to a vehicle is essential for this role.

As a seasonal warden you will be working on the SPA often in a variety of weathers. There will also be an element of office work required. Although the work will involve regular liaison with the SAMM wardening team, SPA staff and other land management staff, there will be a significant element of lone working.

It should be noted that as the role involves engaging directly with the public, the work may include potentially confrontational situations. However, the safety and wellbeing of its staff is of paramount importance to Natural England, which is committed to ensuring its staff undertake their roles in a healthy and safe working environment.

Flexible working patterns will generally be accommodated unless stated otherwise.
